ArticleI The Guidelines are enacted based on the University Act and Regulations

Governing Credit Transfer and Exemption of Wenzao Ursuline University of Languages.

ArticleII Center for English Language Teaching is responsible for matters related to

credit transfer and exemption. Standards follow the regulations in the implementation guidelines unless stated otherwise.

ArticleIII Reviews of credit transfer and exemption in General English Program are

evaluated by the Center for English Language Teaching. Regulations are enacted by the Center for English Language Teaching. The criteria on credit transfer and exemption are as follows:

- 1. Credits to be transferred must be the same or more. Exemption is made to subjects with lesser credits.
- 2. If transfer credits are insufficient, applicants have to take subjects referred by the Center to fulfill the requirement.
- 3. Reviews on credits transfer or exemption must be approved by the Center. The Center may request the applicant to take test(s) where see fit. Credit transfer or exemption would be granted once the test(s) are passed. However, all these processes should be completed before the due date for subject adding and withdrawal.

ArticleIV Qualifications of applying credit transfer and exemption are as follows:

Students who have earned credits of the same or equivalent subjects
within six years before admission to Wenzao University from
universities or colleges approved by the Ministry of Education or from
the Division of Extension Education of Wenzao University can apply
for credit transfer and exemption, exclusive of the credits earned from

- other schools' extension education courses. The application is done only once during the prescribed time assigned by Wenzao Admission.
- 2. For 4-year college students who have completed Level 9 can waive the subjects in General English Program. The remaining credits should be earned in accordance with the curriculum charts stipulated by relative departments.
- 3. For 4-year college students of the Day Division who have reached CEFR C1 as listed in Wenzao University's conversion chart may apply with official transcript reports for waiving 8 credits in General English Program. However, the remaining 16 credits should be earned from EMI courses.
- 4. International and overseas students with official documents showing identity as a native speaker of English or birth in an English-speaking country may apply for waiving 8 credits in the General English Program. However, the remaining 16 credits should be earned from EMI courses.
- 5. Students with the following qualifications based on the criteria of English proficiency tests can apply to waive the course(s):

- 6. Short-term study program participants: students who has completed the overseas English short-term study program organized by the University can apply to CELT to waive a maximum of 4 credits from the General English Program.
- ArticleV Upon transition from the old curriculum to a new one, students who are required to make up credits due to reasons such as missing subjects, transferring from other departments or other universities, or resuming schooling will have to take subjects based on the new curriculum. When subjects prescribed in the old curriculum are no longer available in the new curriculum, CELT directors may determine the waivable subjects. As circumstances require, students may be permitted to study subjects offered by another department, system, division, or university.
- ArticleVI The regulations become effective after approval by the Curriculum Designing Group of the Center for English Language Teaching, the College Affair Committee of the College of International Culture, Education, and Foreign Affairs, and the Academic Affairs Committee. Amendments follow the same procedure.
